- (b) To establish, run, manage and maintain schools with objective providing nursery, pre-primary, primary, middle, secondary, senior secondary and higher education to children and students by seeking recognition with affiliation with education department already in existences by the Government.
- (c) To provide food, accommodation, education and caring for poor and orphan children through sponsorship.
- (d) To care widows, aged people and all needy people and helping them financially.
- (e) To engage in social service activities aimed at improving the living condition and general welfare of the poor particularly farmers and other working people as well as poor and indigent persons of whatever occupation without respect of race, community, caste or creed.
- (f) To undertake welfare activities for socially backwards, Handicaps, Tribal for promotion of their moral, social, educational and physical improvement. To assist Govt./NGO's to arrange medical/ cultural/ educational and food facilities in backward /tribal area
- (g) To establish, maintain, take over management, administer or run any institutions, colleges engaged in the imparting of education to students up to any level that may be found necessary and/or desirable.
- (h) To engage, assist or undertake various social service activities such as sanitation, public health, establishment of libraries, social welfare activities, family welfare, relief to the affected in times of flood, famine, pestilence and other calamities caused by nature and man.
- (i) To establish Rehabilitation centers for poor and disabled and aged persons, street children. To undertake care and support services for the HIV/AIDS affected people and people suffering with leprosy and other chronic diseases.
- (j) To establish Bible college/s or to help and construct Church/es to in the pursuit of realization of the truth of the Bible.
- (k) To undertake outreach ministries, children ministry, women ministry, cottage prayer meetings, street prayer meetings, gospel crusades and other social service activities at grassroot level to carry the gospel to need and deserved people, groups and all relevant places.
- (l) To open branch/es, educational institutions, plant Churches, medical care and health centres, religious training centres, cottage prayers, house meetings and faith centres, seminars, conferences, public meetings etc' to promote the teachings of the Lord Jesus Christ as found in the Bible.

- (r) To open found, establish, promote, set up, maintain, assist, finance, support and or help the various community development programs and or activities as well as to assist in the monetary contribution or other assistance in construction development of, community hall, night shelter, health care centre's, home-stay, rehabilitation centre, old age or children shelter home, indoor or outdoor for the use of and welfare of the general public.
- (s) To render services for the blind, deaf, unemployed youth, widows, physically, mentally and socially handicapped, poor and chronic disease patients and also to care for the orphans and to be involved in famine, flood and riots relief programme irrespective of caste, creed, colour or religion.
- (t) To develop, support, promote, execute, train and offer consultancy, in setting up educational institutions and in modern agricultural, horticultural and farming activities in an eco-friendly sustainable environment to the farming community.
- (u) To start, maintain, promote and/ or aid old age homes, homes for handicapped, mentally retarded persons, street children etc.
- (v) To spread the message of God by means of lectures, talks, discussions, seminars, symposia, conferences, competitions, research and study visits, tours, excursions, exhibitions, debates, cinema, audio-visual programs, the artistic and other cultural activities, sports and games.
- (w) The Trust shall however, have power to levy any nominal and reasonable charges from the students, beneficiaries or others benefitting from the institutions and establishments maintained and conducted by the Trust, and the Chairman shall have the power to exempt deserving students, beneficiaries, or others from payment of any charges that may be collected from time to time as per the Government norms.
- (x) To acquire and maintain the movables and immovable properties for achieving the said objects.
- (y) To do such other lawful things which are conducive to the attainment of the above objects.
- (z) To advance any other objects of general public utility.

The trust shall be an irrevocable public educational, cultural, charitable trust for the benefit of all persons belonging to whatever community irrespective of Caste, Creed, gender or Religion, the Trustees shall stand possessed of the said amount of corpus endowed by the Authors of the trust and such other properties (both movable and immovable) as may be acquired from time to time by the Trust, by purchase, exchange, grant, allotment, subscription, endowment, donation, contribution, or in any manner to whatsoever (all of which shall be designed as Trust properties) on the Trust herein mentioned.

#### 4. NUMBER OF TRUSTEES:

The number of Trustees including the Managing Trustee or Chairman of the Trustees shall not be less than 3 and not more than 9 persons. The Board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper. Except trustees no other person has any right or claim over the trust.

**5. DURATION OF THE BOARD:**

All positions of Trustees shall become vacant after 3 years tenure, save and except the position of the Managing Trustee. The author shall be a life member unless he voluntarily decides to resign or appoint another person.

The Managing Trustee, until he or she found guilty of activities against the objects of the Trust, shall remain responsible for carrying out the objects of the Trust.

The Board shall strive to appoint persons as Trustees with care, on the basis of their commitment and service to Trust's objects and similar objects whenever filling vacancies.

**6. CHAIRMAN:**

There shall be a Chairman for the administration of this trust, nominated by Board of Trustees, who is the Managing trustee as specified in para (4) above for such period, in such manner as may be specified in this behalf. The Managing Trustee acts as Managing Trustee-cum-Chairman.

**7. MANAGING TRUSTEE/CHAIRMAN:**

- (i) The day-to-day administration of the Trust shall be looked after by the Chairman under the guidance, suggestions and supervision of the Board of Trustees.
- (ii) The Board of Trustees shall nominate one amongst the trustees as specified in para (4) above to be the Managing Trustee, who shall hold office for such period, as may be decided by the Board of Trustees.
- (iii) The Chairman shall perform all functions, discharge such duties as or specifically entrusted to him/her in writing by the Board of Trustees.
- (iv) The authorized signatories i.e. Chairman and Treasurer or Chairman and Secretary shall have power and authority for and on behalf of the Board:
  - a) To carry out the resolutions of the Board
  - b) To execute all documents on behalf of the Board.
  - c) To sign papers, receipts and documents,
  - d) To pay money due by the Trust and demand and get receipts therefor;
  - e) To demand and receive moneys due to the Trust and issue receipts for the money so received.

**8. VACANCIES:**

Any vacancy among the Members of the Board of Trustees may be filled by the trustees as specified in para(4) above or their successors and they shall hold office for such duration as may be specified by the Board of Trustees.

**9. TERMINATION OF OFFICE OF THE TRUSTEES:**

  - i) if he dies,
  - ii) if he resigns,

- iii) if he is adjudged insolvent or found guilty of an offence involving moral turpitude.
- iv) if he is found to have acted against the interest of the Trust.
- v) if it is decided by the Trustees specified in para(4) above that his continuation in the Office is against the interest of the Trust.
- vi) Upon expiry of the period up to which the Board of Trustees have nominated the trustee.

**10. QUORUM OF BOARD MEETINGS:**

The Trustees shall ordinarily meet at least once a year or as often as may be necessary for the satisfactory conduct of the affairs of the Trust. 7 days Notice shall ordinarily be given in writing or orally for a meeting of Board of Trustees.

A Quorum for the Meeting of the Board of Trustees shall be  $2/3^{rd}$  of the members. In the event that the meeting is adjourned for lack of a quorum, the adjourned meeting shall require no quorum and can be held within the period of one month but not earlier than twenty-four hours from the time of the original meeting.

The Managing Trustee shall preside over all meetings of the Board and shall have the right of the casting vote. The right of the casting vote shall be available to the Managing Trustee only and to no other Trustee, even if such Trustee has been authorized by the Managing Trustee to preside over such meetings.

A minute book shall be kept by the Chairman. Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the board of trustee shall be entered in the minute book and shall be signed by the Chairman of the Meeting.

**11. VOTING:**

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The Chairman of the Board of Trustees shall have a casting vote in the event of equality of votes, in addition to his own.

**12. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES:**

- (a) All property of the Trust Movable or Immovable or of any other kind, shall be vested with the trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.
- (b) In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions:

- (i) To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any Movable Property.
- (ii) To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.
- (iii) To accept gifts, donations, endowment and contributions from other services, amounts collected as fees for conducting trainings, seminars, workshops, income from other sources including grants-in-aid from institutions or individuals within or outside India for the Trust and shall be treated as the income of the Trust.
- (iv) (a) To raise loans, to receive monies, securities or other movable property on behalf of the Trust.  
(b) To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.
- (v) To award scholarship and make donations calculated to promote the objects of the Trust.
- (vi) To enter into contracts, or engagements on behalf of the Trust.
- (vii) To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the Board of Trustees may deem fit, in accordance with the provisions of Sec. 13(1) (d) r.w.s 11(5) of the Income Tax Act, 1961 and under section 20 of the Indian Trust Act, 1882. The Income of the Trust will be for the benefit of all/open to all irrespective of caste, community, religion, colour, sex etc., The Trust activities are strictly working in laws of the land.
- (ix) To sell, transfer or otherwise dispose of any immovable property of the trust with the majority of the Board of Trustees to resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust.
- (x) To appoint Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.
- (xi) To consider such proposals submitted by Sub-committee appointed by Board of Trustees and allocate such funds if necessary as deemed necessary for the implementation of the programs.
- (xi) To appoint such employees on such terms and conditions as the Board of Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal. If any legal matters regarding the trust activities that shall be settled in Bapatla courts or any other courts as decided by the Board resolution only.

- (xiv) Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely.
- (a) All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.
  - (b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
  - (c) The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.
  - (d) The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
  - (e) Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the Board of Trustees in the carrying out of this trust.
  - (f) Cost and expenses of keeping the trust property in good condition.
  - (g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
  - (h) The architect's fee and legal charges and fee payable to other professionals engaged in the course of administration of the trust.
  - (i) All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes hereof or which may be incidental thereto.
  - (j) The Chairman may, in case of emergency, direct the execution of the any work or the doing of any act which is not provided for in the Budget of the year and the immediate execution of which is in his opinion necessary for the preservation of the properties of the Trust.

The Chairman and the other trustees may reimburse themselves or pay or reimburse out of the trust moneys in their hands all expenses properly incurred by them in or above the execution of the Trust and in discharge of the duties imposed on them under this Trust.

### 13. BANK ACCOUNTS:

- (i) The authorized signatories of the Trust shall have the power and authority for and on behalf of the Board.
- (ii) The Board of Trustees may open such Bank Account or Accounts in any of the Banks in the name of **SHARON CHARITABLE TRUST** such accounts shall be jointly operated either by the Chairman and Treasurer or Chairman and Secretary.

- (iii) The trust may open Bank Account/s in the name of institution/ organisation founded by the Trust. Chairman and Treasurer or Chairman and Secretary are authorized signatories of the Trust to deposit and the funds of the Trust in such accounts and to operate on such accounts on behalf of the Trust.
- (iv) The authorized signatories of the Trust to make, draw, endorse, accept, sign, negotiate, transfer cheques, promissory notes, hundies, bills of exchange, bills of lading, railway receipts, warrants and other negotiable or transferable instruments, Government securities and other securities.

#### 14. APPLICATION OF THE PROPERTIES OF THE TRUST:

The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided however that this shall not preclude payment of any remuneration or allowance or giving of residential accommodation or any perquisites to any trustee in connection with the work carried out by him/her for the purpose of the Trust.

The income or funds of the Trust shall be solely utilized for furtherance of the objects of the Trust and no part of it shall be distributed among the Trustees or members of the Trust by way of profit or divided or otherwise.

And the Trustees are not entitled to any salary or any benefit out of the trust. They are only the custodian of the trust properties.

At present the Trust has no property or assets either movable or immovable. Other than the Trust Fund donated by the FOUNDER/ SETTLOR a sum of Rs. 5,001/- (Rupees Five thousand and one only).

#### 15. ACCOUNTS & AUDITING:

The Board of Trustees shall keep or cause to be kept true account of all moneys and properties received and expended by the Trust and of the matters in respect of which such receipts and expenditures took place and of the assets and liabilities of the Trust.

The Accounts of the trust shall be audited by a Chartered Accountant every year i.e., commencing from 1st April to the 31st March of next year. The Auditors shall have access at all reasonable time to all the books, accounts and relevant papers of the Trust.

#### 16. DEFECTS OF PROCEDURE IMMATERIAL:

No act of Trustees shall be invalidated by reason only of any vacancy in the Board of Trustees or any irregularity in the proceedings of the Board of Trustees or any Committee thereof.
